Art. 1 The preamble constitutes an integral part of this agreement.

dicated by the Refugio;

- Art. 2 The University of Siena is committed to providing the Client the agreed services to the event described in the annex, under the conditions mentioned below.
- Art. 3 The specific services requested, as well as the limitations to their use, are set forth by the parties in Annex, which constitutes an integral part of this agreement.
- Art. 4 The total amount due for use of the venue and services is fixed in the budget estimated, VAT 22% included, and it shall be paid within sixty (60) days after the end of the event. Upon receipt of payment the relevant invoice will be issued.



- Art. 5 If the services requested by the Client differ, qualitatively or quantitatively, from those agreed on in Annex, this will be arranged through the exchange of letters or e-mails, which will also include any changes to the costs. Any changes will be considered in the final account of charges and applicable invoice.
- Art. 6 Both parties are entitled to appoint their own representatives to agree on any changes to Annex.

 The person in charge for the University of Siena is Chiara Roscino, for the Client is Mrs/Mr
- Art. 7 The Client undertakes to use the venue with care and will be held liable for any damage caused during its use of the venue.
- Art. 8 The Client represents that it has seen the whole facility and has found it to be fully satisfactory and suitable for the planned use. The Client also acknowledges that it has read and accepts the regulations under the preamble, which can be found on the web site https://en.unisi.it/university/residence-il-refugio.
- Art. 9 The Client exonerates the Granting party from any and all liability due to the unforeseen interruption of any services caused by any reasons beyond the Granting Party's reasonable control, as well as any accidents caused by careless or inappropriate use of the Refugio venue.
- Art. 10 For any aspect not covered by this agreement, the parties will refer to the provisions of the Italian Civil Code as well as usage and custom on the matter.

For the purposes of arts 1341 and 1342 of the Italian Civil Code, the parties declare that they expressly agree to the provisions of arts 3, 5, 7, 8, 9, 10 herein.
