NOTICE OF SELECTION

ERASMUS FOR STUDY 2024/2025

Selection process for the Erasmus for studies mobility for academic year 2024/2025 in the framework of the Erasmus+ Programme.

Art. 1 - Eligible Students

Students enrolled in AY 2023/2024 in any course of study at all levels at the University of Siena are eligible, excluding "Invest your talent in Italy" recipients.

Note, however, that:

- Students enrolled at present in their third year of a first-level course who plan to carry out the mobility abroad during the first year of a second-level course, should submit a plan of study describing the Master level courses that they plan to take at the University of Siena in academic year 2024/2025 and will be permitted to study abroad only after enrolment in academic year 2024/2025. Assignees who end their career between September and December 2024 are allowed to start their mobility only in the second semester of AY 2024/2025;
- 2. Students who have already completed an Erasmus mobility (Study and/or Traineeship and/or ICM) can submit the application for the Erasmus for study 2024/2025 mobility in accordance with the the following restrictions:
 - a) Three-years undergraduate, Masters, and PhD students may not receive monthly Erasmus benefits for more than a total of 12 months.
 - b) *Single-cycle* (five-year combined bachelor and master degree program) students cannot study abroad for more than a total of 24 months.
- 3. Erasmus mobility is not compatible with part-time student status and with the enrolment to single courses.

Art. 2 - Study-Abroad Period and Acceptable Activities

Assignees of an Erasmus destination will study at the host university for 2 to 12 months between 01/08/2024 and 31/07/2025.

Each exchange has places and months agreed between the universities and the period cannot in any case be shorter than 2 months (60 days). The period originally planned may be reduced before the mobility begins if approved by the host university. It may also be extended after the mobility begins, if approved by both universities.

According with the host university, it is possible to carry on a blended mobility, that is partially in presence (minimum 2 months) and partially in virtual modality.

Only students enrolled in AY 2024/2025 will be allowed to carry out the Erasmus for studies mobility, excluding those students intending to graduate by April 2025 and applying for the suspension of the 2023/2024 fee payment and enrolment.

If the mobility begins before the opening of enrolment procedures at the University of Siena, the student must regularize his/her position as soon as possible.

Possible activities during the period of study abroad are:

1) attending courses

2) taking exams

- 3) thesis preparation (if allowed by the receiving university)
- 4) combined mobility study + traineeship. In this case the traineeship activities have to be carried out in a complementary way to the study activity and at the receiving university

In the cases 3) and 4) it is necessary to check in advance (better before application) if the receiving university is available to supervise a traineeship and/or a research for thesis: due to the specificity, such an opportunity is not always guaranteed by all the receiving universities.

The students must pass at least one of the exams indicated in the Learning Agreement. This rule does not apply to those who will carry on thesis preparation activities.

During the mobility, the assignee will have the Erasmus student status and they will be full-fledged enrolled in the receiving university, which will not ask for tuition fee payment. Nevertheless, the assignee will have to fulfill the University of Siena obligations: pay the tuition fee 2024/2025, fill the study plan 2024/2025 and comply with the other fulfilments.

Finally, during the mobility the career is suspended and no exam can be taken as well as other didactic activities delivered by the University of Siena (not even on-line). The career will be re-activated after the end of the mobility, after checking that the final documentation has been correctly delivered and after verifying the absence of any arrears to be paid (due to the possibility of partial or total refund to be made by the student).

It is not possible to take exam at the host University after the end of the mobility. If in the host University the examination session is after the planned mobility period, the student should have to require an extension which could be carried on in presence or in virtual modality. In both cases, the career will be reactivated after the definitive end of the mobility and the mentioned checks.

Art. 3 - Host Universities

Each destination is the result of an inter-institutional agreement Erasmus+, coordinated in the didactic sphere by two professors: one from the University of Siena and one from the host University.

Destinations are grouped into three macro areas (Economics-Law-Political Sciences, Humanities, Experimental Sciences-Medicine): the tables are available at https://en.unisi.it/international/mobility-abroad/study-and-research-abroad/erasmus-studies

In selecting their destination, students must carefully read the instructions provided next to the name of the foreign university:

- <u>Agreement ID number</u> starting with BA assigned to each destination listed both in the table and in the online application page;

- <u>Level of study</u> to which the grant is restricted, corresponding to the level of study programs that will be available at the registered foreign university (L_UNDER: bachelor; L_GRAD: Master; L_POST: doctoral or postgraduate courses). Many host Universities do not permit attendance of courses of lower or higher levels than the ones students are attending at their home University;

Students can apply for the destinations reserved to the level of study in which they will be enrolled in the academic year during which the mobility will be carried on. In some European Universities (such as the Spanish and Greek ones) the first cycle of study has a duration of 4 years, which can be, in some cases, accessible also to students enrolled in a second cycle degree course.

- <u>Subject area</u> must correspond to the type of courses available at the registered foreign university (sometimes exclusively). In particular, students should select subject areas similar to those of their degree course in Siena;

- <u>Level of language proficiency</u> and/or international certifications of language, both recommended or requested (often to be sent to the University before the mobility, for acceptance at the receiving University itself).

-notes which have been communicated by the partner Universities.

The candidate may choose up to 4 destination to be listed in order of preference. The agreement identification number will help verify the exact correspondence between the destination chosen in the table and that one in the online application.

Destinations indicated in this notice of selection and the related information on places, language requirements, and application deadlines for the host University, may vary due to decisions taken by the partner Universities, which are unknown at the moment of the publications of the notice of selection.

When choosing the destination, it is responsibility of the student to verify the academic offer of the host University, language requirements, application deadlines, and, for international students, also entry and residence rules as well as the renewal of the "permesso di soggiorno" before the starting of the mobility, if the case of it expiring during the mobility.

Art. 4 - Application procedure

The application has to be submitted on-line at the page https://segreteriaonline.unisi.it/Home.do > International mobility outgoing > Mobility application.

Applications will be accepted from the moment of the publication of this notice of selection, until the 5th February 2024 at noon, deadline of this notice of selection. The deadline for application cannot be postponed for any technical problems.

Once submitted, the application cannot be modified or amended.

A green marking at the end of the procedure indicates that the application has been submitted correctly. If the control colour is yellow, the application is incomplete and cannot be assessed.

The application cannot be submitted by:

-students enrolled in master degree who intend to carry on the mobility during a PhD course

-students who have finished the maximum of Erasmus months at their disposal for the study cycle during which they intend to carry on the mobility.

In the meantime, candidates are invited to check their income category in the Segreteria on-line (code from 0 to 9) and report inconsistency to the office in charge. For those enrolled in a third cycle course, they must give consent to the INPS for the access to their ISEE certification; otherwise, the higher range of income will be considered.

Art. 5 - Evaluation of Applications

The evaluation will be calculated based on the following items that will be summed:

- 1) merit score (max 30 points):
 - for students enrolled in I level courses (L1, L2, LC5, LC6, LM5, LM6):
 - 0.8 * average of grades awarded + 0.2 * (30 * credits earned/credits required);
 - for students enrolled in II level courses (LM, LS):
 - 0.15 * average of grades awarded + 0.15 * (30 * credits earned/credits required) + 0.7 * mark on access degree (in thirtieths);
 - for students enrolled in III level courses (M1,M2, D2, S1,SP2,SP3,SP4,SP5,SP6):

mark on access degree (in thirtieths);

2) proficiency in a foreign language (max 30 points): see art. 6 and tables attached;

3) congruence of the study abroad programme and the applicant's motivation (max 30 points): to be assessed by the Coordinator. The coordinator may approve the destination ranking elaborated by the system on the sum of 1) and 2) scores without adding any points.

The final mark on access degree to a second cycle degree course (on 110 basis) must be present in the Segreteria online.

As for point 1, the reference date is February 17th, 2024.

Each preference will be assessed in accordance with the mentioned criteria. As a result, evaluations may differ from one preference to another.

For those with the same total score, the software Esse3 managing the ranking procedure will apply the standard criterion.

Art. 6 - Evaluation of language proficiency (University Language Centre)

As for art. 5, point 2, proficiency in a foreign language will be assessed for each of the destinations chosen (according to the languages specified in the table of destinations as explained in Art.3). The level assessed (regardless of the requested or recommended language level) will be used for the sole purpose of the application. Should several languages be mentioned in the exchange destination and should the candidate be proficient in more than one of these, the system will consider the language with the highest degree of proficiency.

Native speakers too must respect the following rules.

Language skills will be assessed on the basis of proficiency tests and language exams taken or any certificates held by the candidate. These data will be extracted from the CLA database and from the online student's record book. Proficiency tests must have been taken and passed, without exceptions, by February 2nd, 2024.

English language

For English language proficiency, applicants who already hold a qualification (idoneità) or certificate recorded by the University of Siena in the current or recent academic career or an exam mark out of thirty will be evaluated automatically and need not provide any other documentation.

Applicants (PhD students included) who have not already presented an international certification must do so by sending it to CLA (infocla@unisi.it for students from Siena and cla-ar@unisi.it for students from Arezzo) by 8/2/2023, writing "candidatura bando Erasmus" ("Erasmus application form") in the subject line, and wait for a confirmation of receipt. Should the certification already produced at the CLA be of a higher level than that recorded in the student's career, the actual level of the certification will be automatically taken into account (information already held by the CLA).

For those enrolled in a degree course held in English, a B2 English level is automatically recognised, unless the student presents an higher level certification.

Candidates (PhD students included) who have taken an English exam or proficiency English test at a previous university course of studies outside our University, not more than 4 years before their enrollment at the University of Siena, must send to the CLA (infocla@unisi.it for students of Siena and cla-ar@unisi.it for students of Arezzo) no later than 5/2/2023 Ref.: "Erasmus call application", the entire previous course of studies documentation, including all exams passed and dates in which they were taken and the program of the English exam which must mention the language level reached.

Students enrolled in Scienze della Comunicazione (Communication Sciences), Strategie e Tecniche della Comunicazione (Communication Strategies and Techniques), Language and Mind, Public and Cultural Diplomacy who have obtained from the Teaching Committee the validation of an exam or language proficiency test taken in a previous course of studies at another University and which is not in the online student's record book yet, must report this to the Ufficio Studenti DISPOC (DISPOC Students' Office) (didattica.dispoc@unisi.it) who will communicate it to the Centro Linguistico (CLA-Linguistic Centre).

Other languages

For all other languages (French, Portuguese, Spanish and German), candidates (PhD students included) who took a proficiency test or an exam with a grade in thirtieths in their current or immediately preceding degree course (always at this University) will be assessed automatically. If you believe that you have skills that are not certified, you must contact the relevant CEL (Language Expert) to take the proficiency test. The same applies if you have a certificate: you must present it to the relevant CEL, which will examine it for possible validation. The contact details for CELs in languages other than English are published on the CLA website - under the section "Other languages" (https://www.cla.unisi.it/it).

The students in Arezzo have to give the documents to CLA (cla-ar@unisi.it), in case they had not done it already.

General rules

Those who have already submitted a certificate to the CLA and obtained validation with a score under another Overseas or Erasmus mobility call in 2022 or 2023 need not resubmit it, as it will be automatically taken into account for the purposes of this ranking.

Documentation produced without a clear indication of the language level according to the parameters of the Common European Framework of Reference for Languages (A1, A2, B1, B2 etc.) and documentation delivered after 5/2/2023 will not be evaluated in any way.

The scores relating to language assessment (as indicated in the table at the end of this notice of selection) will be published on the webpage https://en.unisi.it/international/mobility-abroad/study-and-researchabroad/erasmus-studies. Applicants will be notified by e-mail and will have the opportunity to report any anomalies to outgoing@unisi.it no more than 2 days after the date of publication. No further objections will be accepted after this date.

In the event that the level of knowledge of the foreign language does not comply with that required by the host university, access to the ranking for the destination assignment will not be blocked. Students will then have to give confirmation of their linguistic knowledge to the future host University, according to the modalities requested by it.

In the event that a candidate is not in possession of certifications proving the level of linguistic knowledge, they will be awarded a score of 0.

Art. 7 - Assignment of the Erasmus destinations

Despite their own name being listed in each rankings of the destinations chosen, only one destination is assigned by the system and it cannot be changed unless:

- the partner university closes the exchange after assignment
- a geopolitical crisis occurs in the receiving country

Assignment list publication. The list of assignees of the Erasmus destinations, together with the rankings of the grant recipients approved by the General Director, will be published at https://en.unisi.it/international/mobility-abroad/study-and-research-abroad/erasmus-studies Students will also be notified by e-mail (@student.unisi.it) together with all the necessary indications regarding the steps to follow in the Segreteria online during the 3 days after the publication.

<u>Nomination</u>. The International Mobility Office will then communicate the names of assignees to the host Universities, indicating periods and duration, and request that information material and forms (Application Form, Learning Agreement Accommodation Form etc.) be e-mailed directly to the student, as these are necessary to organize the mobility period and complete enrolment.

The status of Erasmus students will be confirmed only if the assignees comply with the procedures set out in this Notice. They are also subject to acceptance by the host universities.

Should students change their degree course after assignment, the mobility can be carried out only if the new course is compatible with the destination.

Art. 8 – Assignee responsibilities

After nomination sent to the receiving university:

Once selected, students who are not citizens of the European Union must obtain information regarding visa requirements and economic conditions required by the country in which they will carry out the mobility by contacting the embassy in Italy.

Should the Italian permit of stay expire during the mobility period, it must be renewed before leaving Italy. Participants have to comply with the application procedure of the receiving university in order to obtain the final acceptance of the mobility and the study plan. It is the student's responsibility to reach the level of language proficiency required and produce any relevant certificates by the deadline specified by the foreign University.

PLEASE NOTE: students who will start their mobility at the beginning of the 2024/2025 a.y., and who will not have sent the proof of the beginning of the mobility (Erasmus Certificate) by November 15th, 2024, will be considered as renouncing to their mobility.

Art. 9 – Financial Contributions

Erasmus+ grants are to be considered as a contribution to the expenses related to the period of mobility abroad.

The amount of financial contribution varies basing on the host Country, on the modality of the travel and on the fact of being subjected to a socio-economic disadvantage situation.

9.1 European grant

All mobilities are granted.

The European financial contribution to Recipients, in accordance with the Ministry of Education, University and Research (MUR) decision for 2021/27 mobilities, establishes the following amounts:

Mobility to:	Denmark, Finland, Iceland, Ireland, Liechtenstein, Luxembourg, 350 Euros /month Norway, Sweden and United Kingdom	
Mobility to:	Austria, Belgium, Cyprus, France, Germany, Greece, Malta, Portugal, The Netherlands, Spain	300 Euros/month
Mobility to:	Bulgaria, Czech Republic, Croatia, Estonia, Hungary, Latvia, Lithuania, North Macedonia, Poland, Romania, Slovakia, Slovenia, Turkey	250 Euros/month

9.2 Inclusion grant

In order to facilitate the access to the mobility for the students with fewer opportunities, a \in 250,00 contribution will be provided for the following cases:

a) economic disadvantage

- b) refugee or temporary protection status
- c) with minor children
- d) workers (if the status has been already recognized by the University of Siena)
- e) orphans who lost at least one parent
- f) disability

As for the condition indicated at the letter a), the rule applies for those who have an ISEE of maximum € 26.306,25. The condition is verified by the International mobility Office at the moment of the approval of the ranking, basing on the information that are available in the Segreteria Online.

As for conditions indicated at the letters b), c), d), e), f), it should be provided appropriate documentation to be attached to the grant agreement.

Moreover, for the students with fewer opportunities who should have a needing related to physical, mental or health conditions, it will be possible to present a request for the additional costs which are directly connected to the mobility and which cannot be covered with the integration contribution to individual support. The modality through which it will be possible to require such contribution, will be communicated successively to the assignation of the mobility.

9.3 Ministerial integration

In order to facilitate student's mobility, the University of Siena will provide financial integration contribution financed by the Ministerial *"Fondo Giovani"*

The contribution will be based on the ISEE range.

It is specified that such contribution will be subjected to availability of funds.

The rankings will be based on the combined sum of the merit score and the language proficiency score, and grants will be assigned until funds run out. The amount of the MUR monthly integration will be calculated on the basis of the student's economic condition (i.e. income code from 0A to 4k) present in the Segreteria online when destinations are assigned. The monthly amount will be published in the ranking list.

9.4 The Regional Agency for the Right to Education grant

The Regional Agency for the Right to Education (DSU Toscana) provides economic contribution for the participation to international exchange mobility programs. The contribution is reserved to the students who have been awarded with the scholarship for the a.y. 2025/2025 and are assignees of an Erasmus mobility for the same academic year.

This additional contribution is an all-inclusive monthly flat-rate contribution.

9.5 Green travel grant

An ad hoc contribution is contemplated for so-called "green" trips in both ways to reach the host site through sustainable means of transport (i.e. bicycle, bus, carpooling, train). The contribution will be 50.00 euros + 2 days of individual support (monthly amount/30 days). Plane, boat, car and motorcycle are not considered sustainable means of transport. This contribution will be calculated at the end of the mobility after the delivery of the final documents, and so included in the balance.

9.6 Department of Philology and literary criticism (DFCLAM).

Thanks to MUR financial support for the excellence departments, the Department of Philology and literary criticism will support the Erasmus for studies mobility with 13 scholarships of Euro 1.000,00 each (see table), as integration to the European grant, thanks to the ministerial funds as Excellence Department. The scholarship will be assigned to students enrolled in the Master courses of Classical Literature and Modern Literature and the Bachelor course of Studies in Literature and Philosophy (SLP) and Languages for Intercultural and Business Communication (LIBC), and selected by DFCLAM, who complete a mobility period of at least 4 months and acquire at least 18 university credits. Students who do not fulfil the requirements will be asked to fully or partially refund the grant.

The grant will be paid to the assignee in one lump sum after delivery of the Erasmus certificate and the travel ticket or boarding pass at the beginning of the mobility.

The Department reserves the right to assign the scholarship differently as a consequence of the number of applications received for each category and following the rankings outcomes.

9.7 Payment modalities

The European economic grant, indicated at Arts. 9.1 and 9.2, will be provided in two instalments:

- 80% of the total grant within 30 days after delivery of the Erasmus certificate indicating the arrival date and the boarding pass or travel ticket. - the balance after completion of the After the mobility procedure. Please see the procedure dedicated to documents delivery at the webpage Erasmus for studies > after the mobility https://en.unisi.it/international/mobility-abroad/study-and-research-abroad/erasmusstudies/after-mobility

The Ministerial integration indicated at the Art. 9.3 paid in two instalments:

- 50% after delivery of the Erasmus certificate;
- the balance after completion of the After the mobility procedure

If the <u>period</u> of the mobility is shorter then the one indicated in the Grant Agreement (please note that the "in presence" period should always be at least 2 months long), the following rule applies:

- 1. if the difference is more than 5 days: the total grant will be calculated on the period of the Erasmus Certificate;
- 2. if the difference is less than 5 days: the total grant will be calculated on the period of the Grant Agreement.

However, if the real mobility period is more than 5 days longer than the one indicated in the Grant Agreement, the total economic contribution will be calculated on the basis of the period indicate in the Grant Agreement, and the exceeding period will not be granted.

Art. 10 – Refunding of grants

The participant may not receive the balance or be asked to refund the University in the following cases:

- failing in the EU survey completion: the balance/s is/are not transferred
- mobility period shortening: refund of the difference between the advance payment/s and the grant/s calculated on the Erasmus certificate
- failing in the Erasmus certificate delivery: the mobility is cancelled and it will be requested the refund of the total grant/s
- failure of all the exams indicated in the Learning Agreement: it is considered as a "zero grant" mobility, and the total refund of the grant/s is requested.

Art. 11 – Insurance coverage

Each assignee is covered by an insurance issued by the University of Siena for personal injuries and liability in the case of slight negligence while carrying out their mobility (see the Sintesi in inglese delle Polizze Assicurative RCT/O e Infortuni di Ateneo in https://www.unisi.it/ateneo/lavorare-unisi/servizi-di-economato/assicurazioni).

The T.E.A.M. – European Health Insurance Card covers the health issues in the European countries (Island, Liechtenstein and Norway included). For additional information, the participants have to address the ASL and visit https://ec.europa.eu/social/main.jsp?catId=1021&langId=en

Art. 12 – Procedure for Recognition of Educational Activities Carried Out Abroad

The University of Siena guarantees the recognition of the activities listed in the transcript of records. The procedure is run by the Students' Office according to the rules stated in the "Procedure for recognizing credits of study or training activities" published on the https://en.unisi.it/international/mobility-abroad/acknoledgement-university-course-credits-obtained-abroad webpage.

In case of research for thesis, part of the credits of the final trial may be recognised as activity carried out abroad according to the "Recognition of credits for first or second cycle degree thesis preparation" published on the https://en.unisi.it/international/mobility-abroad/acknoledgement-university-course-credits-obtained-abroad webpage.

Art. 13 – Additional credit contribution

The University of Siena has allocated funds aimed at supplementing the mobility grants for the most deserving students. At the end of the mobility period, a merit-based contribution will be provided, calculated based on the number of credits obtained during the study abroad period as per the following table. The term "obtained credits" refers to the number of credits recognized in the students' academic career according to the procedures outlined in Article 12.

The amounts will be fixed after knowing the exact number of students who have carried on the mobility and which are eligible for the economic contribution.

To students who have undertaken a mobility for thesis preparation and have been granted a certain number of credits according to the procedures outlined in the document "Credit Recognition for Thesis Preparation during Outgoing Mobility Period," a merit-based contribution will be awarded following the defense of the bachelor's/master's thesis and the subsequent recording of the recognized credits in the academic record.

Art. 14 – Privacy and Confidentiality of Personal Data

As regards the personal data transmitted by candidates with the application to participate in the Erasmus + program, the University of Siena, in line with the provisions of EU Regulation 2016/679, informs that such data will be processed according to the principles established by art. 5 (lawfulness, correctness, transparency, adequacy, relevance, accuracy, minimization of processing, limitation of conservation, etc.) Furthermore, the provision of the data requested with this documentation is mandatory for the purposes of the procedure for which they are collected and will be processed only for the purposes connected and instrumental to the call and, up to the extent strictly necessary, it may be communicated to the data processors appointed pursuant to of article 28 of the EU Regulation (for example, subjects who manage applications in outsourcing or of hosting on behalf of the University).

As an interested party, the candidate may exercise towards the University of Siena all the rights provided for in article 15 et seq. of the European Regulation (access, rectification, cancellation, limitation, opposition, and withdrawal of consent).
