## **SECTION D** DECLARATIONS

Lastly, the undersigned DECLARES that he/she is aware that:

- the career will **end on 30 April 2025**, without any further communication from the administration office, even if there are still credits to be acquired; the career will be closed earlier if the student has acquired all the credits of the chosen single courses;
- enrolment will be considered completed once the following steps have been taken:
  - payment of the enrolment fee of **130 Euros** for **humanities-social studies courses** and of **150 Euros** for **technical-scientific and EU-regulated healthcare courses** (the administration office will indicate methods and timing);
  - payment of the credits (cost per credit: **15 Euros** for **humanities-social studies courses** and **20 Euros** for **technical-scientific and EU-regulated healthcare courses**) amounting to € \_\_\_\_\_ (the administration office will indicate methods and timing);
- it is possible to add one or more training activities by submitting the appropriate request and paying the fee for the number of credits (CFU) added;
- it is possible to replace one or more training activities, **only once** and with other training activities awarding the same number of credits (CFU);
- enrolment on single courses relating to programmes with a cap on enrolment is subject to specific limitations.

**To this end, the undersigned ATTACHES:**

**(for non-EU citizens only) a passport with entry visa for study at university/individual courses and documentation received from the Italian Representation relating to their academic qualification. Appropriate authorization from the staff at the URP – International Place.**
