



## **NEW TUITION FEES FOR FOREIGN STUDENTS OF THE UNIVERSITY OF SIENA**

*On 19 May 2017 new guidelines were issued regarding payment of tuition fees and for enrolment in Siena University courses for the 2017/2018 academic year. For all international students who are not EU citizens or who cannot provide Italian ISEE (the Equivalent Economic Situation Indicator) the fee amount will be determined according to their home country, the course chosen and University merit. These fees apply to students who are not grantees.*

*For students coming from countries which are not mentioned in either list below, the payment will amount to € 490.00 plus € 140.00 for regional tax and €16.00 for a 'marca da bollo' (revenue stamp).*

*Students who enroll in the Dentistry e Dental Prosthodontics Master's degree course (class LM 46) must pay an additional fee of € 1,650.00.*

Fees payable by the students coming from the abovementioned countries will be calculated on the basis of the students' curriculum and their academic progression (group); the maximum applicable amount shall be multiplied by the adjustment coefficient of the relevant country. The amount range is reported in the table below.
